 - B. Approve 2021-22 Public School Calendar *After seeking input from staff and parents a recommended calendar has been finalized. The school year begins Monday, August 16th and ends Wednesday, May 25th. The High School graduation will be Sunday, May 22nd. The High School will host an abbreviated conference schedule and host a curriculum night in the spring. Conferences will be held on a Thursday, November 4th and Friday in November 5th*
 - C. Approve resolution authorizing retransfer of funds from an interfund loan in the amount of \$28,000 from Bond and Interest to Working Cash *This action will pay back the loan from Working Cash to pay the extra bond payment*
 - D. Approve resolution authorizing TRS Supplement Savings Plan. *TRS requires the District adopt a resolution so that the District can work with TRS to provide support to those TRS members who wish to establish a Supplemental Savings Plan.*
 - E. Approve Health Life Safety Amendment to pay for River Bend's portion of a new boiler for WACC in the amount of \$28,270 to be paid over two years (\$13,486 in FY 22 and \$14,784 in FY 23) *The amount has increased from what was originally reported in November*
 - F. Selection of PMA Securities as Underwriter/Placement Agent and Chapman and Cutler LLP as bond/disclosure counsel to the Underwriter/Placement Agent with respect to the District's Alternate Revenue School Bonds, Series 2022 *The selection of PMA will save the district money and provide additional financial services*
