- A. Consent Agenda: Approve October 20, 2021 Regular Meeting Minutes; October Treasurer's Report; and November Bills Recommended for Payment subject to audit *School Board meeting procedure and mandated roll call votes for finance*
- B. Approve the tentative 2021 Tax levy and set Truth in Taxation Hearing for December 15, 2021 The 9.91% levy is recommended, therefore a Truth in Taxation Hearing will need to be held on December 15, 2021
- C. Approve Workman's Compensation Insurance proposal from Illinois Public Risk Fund (IPRF) *The annual premium quote for Workman's Compensation Insurance is* \$43,156, which is an increase of \$5,239 from last year
- D. Approve Estimated Board Member Expenses for the Triple I Conference Estimated Board Member expenses require preapproval and are included in the packet
- E. Approve Health Life Safety Amendment for Middle School Boiler *Gary informed Dr. Hogue that the one of the two boilers at RBMS has an internal threading to the manifold that cannot be repaired. A boiler service company confirmed and said the boiler needed to be replaced. After talking to the District's Architect, using some or all of the HLS funds will provide an option for covering the replacement cost. A cost estimate from the Boiler company will be shared at the board meeting*
- F. Consideration and action on a Resolution abating the taxes heretofore levied for the year 2021 to pay debt services on General Obligation School Bonds (Alternate Revenue Source), Series 2021 of the District *Taxes levied need to be abated in order to use* 1% *funds to make the bond payment for construction projects. This is the first abatement of the* 2021 *Bond series*
- G. Approve declaring surplus goods as presented *Recommendation to approve eight (8) teacher desks, four (4) filing cabinets, ten (10) old smart boards, teacher chares that are not in good shape, and some other small items in the shed that are not being used*
- H. Accept Gifts to the District River Bend Educational Foundation donated \$500 to Robotics and the Albany Food Pantry donated \$2,000 for snacks, milk and the backpack program
