The Regular Meeting of the Board of Education of River Bend Community Unit School District #2, Whiteside County, Illinois, was held on October 19, 2022, at Fulton High School.

President Portz called the Regular Meeting to order at 6:30pm. Upon Roll Call by the Secretary the following members were present: Eric Fish, Andy Meyers, Dan Portz, Jay Ritchie, and Mary Simmons, Absent: Chris Barnett and Jane Orman-Luker, Others present: Darryl Hogue, Superintendent, Virginia Petersen and Jennifer Griser, Recording Secretaries.

Principal Reports. Mr. Gosch recognized junior Nicole Griffith for all her hard work with the Steamer Suite. The high school has hosted over 100 people on the open house type nights to help promote the Steamer Suite. Dr. Hogue would like to promote the use of the suite to more local businesses and also give the business an opportunity to set up a marketing table in the lobby. Mr. Gosch also informed the Board of an update on the new secure office space. Tri City electric will be working with the construction students to oversee the running of the electrical for the new office space.

The Board had no questions for Mr. Henrekin and he had nothing to highlight at this time.

The Elementary school hosted a math night in which Breanna Kastelic presented the math curriculum to parents. Mr. Hoese just returned from a principal's conference where he was able to share "Rocco to the Rescue" and the process of obtaining a service dog certification. The House Day reveal went very well and the feedback was overwhelmingly positive. Mr. Hoese is looking forward to building on this throughout the year.

Dr. Hogue reminded the Board of the Fall Northwest Division Dinner Meeting on October 24, 2022 in Scales Mound.

Dr. Hogue reported on the River Bend Educational Foundation meeting held on October 18, 2022. The first round of Distinguished Steamer banners have been hung up in the schools. The Foundation approved \$7,144 in mini grants for the teachers and approved funds to continue supporting the Mentoring Program. The

Mrs. Schipper provided a curriculum update. She has been busy going over scores and meeting with teachers and providing them with more tools and resources for students to practice skills. Mrs. Schipper also hared with the Board the work that has been done with the District's Graduate Portfolio. This is the first step in competency work. She shared the success indicators and the survey that will be going out to the community for input. Member Portz asked that Mrs. Schipper put an article in the paper to let community members know about the survey and how to access it.

Dr. Hogue recommended approval of the resolution to adopt the 2022 Whiteside County Multi-Jurisdictional All Hazards Mitigation Plan. River Bend is part of this plan as the transportation fleet would be leeded to help evacuate the community in the event of an emergency.

Foundation is also interested in helping fund Fulton Elementary School's new STEAM lab once plans are finalized. The Foundation has spoken with, and is anticipating having, former student Ryan Reynolds as the peaker at the Academic Excellence dinner. Ryan is the strength and conditioning coach for the Kansas City Lhiefs football team.

Dr. Hogue reported on the October 19, 2022, Citizens Committee Meeting. Bob Gosch, Jeremy Leitzen, Kathleen Schipper, Mary Simmons, and Darryl Hogue were in attendance.

- 1. Mrs. Schipper reviewed the graduate portfolio. Mrs. Schipper has created a survey about the graduate portfolio that will be sent out to parents and others in the community. The survey was created to generate feedback on the success indicators of the graduate portfolio and to help frame what those indicators mean. Mrs. Schipper asked for suggestions for improvement of the survey. The survey will be sent out this week.
- 2. Dr. Hogue provided the committee with a document that provides details about the Safe2Help Program. Safe2Help is a communication tool for students and families to report threats, suicide concerns, bullying, and other incidences to adults in a confidential manner. The Safe2Help program will be brought to students in late October or early November.

Dr. Hogue reported on the October 19, 2022, Finance Committee Meeting. Kyle DeMus, Eric Fish, Craig Hafner, Andy Meyers, Rachel Snyder, and Darryl Hogue were in attendance.

- 1. The treasurer's report was not reviewed due to the length of time spent on the auditor's review.
- 2. Kyle DeMus presented the District's audit.
 - a. River Bend's finance status was a 3.8 with a 4.0 being the highest available
 - b. Overall the District had a clean audit and had a few small findings that were reported.
 - c. The District showed improvement in the grant reporting procedures.
- 3. Three levy options were presented flat, 4.9%, and 9.5%. The committee preferred the 9.5% so as to capture all funds available.
- 4. The District has a \$350,000 CD up for renewal in October. The District would like to keep the funds local. Currently Community State Bank is offering 2.25% for 11 months, Dr. Hogue will ask them to honor the 2.25% for 6 months.

Dr. Hogue informed the Board that enrollment is holding steady at 898.

Kyle DeMus from the Benning Group presented the audit to the Board. Overall the District looks very healthy, there were only a few findings but nothing to be concerned about. The District received a rating of 3.8 out of 4, this is still in the highest rating category. Kyle mentioned there is a new standard that has been put into place regarding leases and he will be working with Rachel to make sure that change in reporting process goes smoothly.

Dr. Hogue presented levy options of a flat rate, 4.99% increase, and 9.5% increase. The Board recommended the 9.5% increase so that if the Estimated Assessed Valuation changes the District will capture all available funds.

Dr. Hogue updated the Board on the School Maintenance Project Grant. The bleachers were recently inspected at the high school and it was determined that the West gym bleachers are okay, however the East gym bleachers are showing wear and should be replaced soon. Dr. Hogue will move forward with the grant process to obtain funds for new bleachers in the East gym at the high school. Member Portz asked Dr. Hogue to also check on the status of the bleachers at the middle school to see if those should be replaced as well.
