Qualifications:	1. Holds Illinois Teaching Certificate as required by State certification authorities.

<b>Reports to:</b>	Principal (will work closely with Instructional Coach)
Job Goal:	The Interventionist is responsible for supporting student achievement in the area of Mathematics and Literacy with special attention to Tier II and III instruction. The Interventionist provides small group instruction to students who are struggling academically. This position is also responsible for monitoring, reporting, and communicating student progress and performance.

#### **Performance Responsibilities:**

1. Use data to provide high quality math and reading instruction to small groups

2. Collaborates with teachers, administration, and families to help identify best strategies for students

3. Uses identified research-based interventions and progress monitoring focused specifically on individual student needs.

4. Collaborates with other instructional coaches regarding instructional priorities, data, and progress

5. Collaborates and communicates with teachers, administration and families to discuss student placement and progress

6. Assists with identifying students for placement in intervention groups, including providing diagnostic assessments

7. Assists in the scheduling and assignment of students to interventions

8. Provides input for program development and improvement

9. Attends appropriate professional development trainings to improve knowledge and skills

10. Provides staff development opportunities

11. Conducts or participates in needed parent conferences and telephone conferences

12. Handle school information regarding students in a professional manner. Relate concerns over school philosophy and procedures through appropriate channels.

13. Works with the math instructional coach to develop goals for the district and identify common student gaps in order to suggest curriculum or instructional modifications

14. Performs other related duties as assigned

#### **Risk Management:**

- 1. It has been determined that 5% of the interventionist's time is spent on Risk Management.
- 2. Supervise students at all times while entering or leaving the school, passing, through the hallways, eating in the cafeteria, working in the classroom, or playing on the playground to ensure they are protected from undue exposure to risk situations.
